### **Ministry Updates**

- Faith Formation (Lucas) no report at this time. Confirmation the four fall confirmation classes have taken place. The next eleven classes will be held after the first of the year. - Evangelism (Sandra)-No meeting took place this month. A mailing to the Lakeside zip code is being considered.

- IT/ Communications (Carol) No new information. The fellowship hall and the educational wing are still in need of internet connections.
- Property (Jim S) The circuit breaker had been tripped which caused the heat to shut down in the sanctuary on Sunday Nov. 12. The problem has been corrected. Spring is the time for landscaping the area in the front of the sanctuary.
- Vision (Jim S)-If you have suggestions as to who would be a good fit for the transition team please contact Jim S or Pastor. Seven is the ideal number, it can be increased. The transition team will produce the Ministry Site Profile. Vision propsed we begin the Healthy Congregations program workshops in January. The program is open to all council members, transition team and the congregation at large.

• Financial Report (Paul)- October saw an improvement in offerings. November has also been more positive. We are still under funded for our budget. Jim I. reported that the Kroger revenue stream has dropped due to changes made to their program for contributions. Jim I. mentioned that there is a possibility to do "script" programming. It is based on gift card purchases on-line. The church would get a rebate for purchases. Jim S. can have the program set up tomorrow and have information available to the congregation by Sunday.

Mat moved that council make the script program available to the Christ Lutheran Congregation and friends as an additional income stream. The motion was seconded and passed. Y-8, N-0

Carol suggested that Thrivent be contacted to help members apply for grants for church expenses and projects.

  provided for each of the session. Donations could be made to cover that cost as
  well.

Jim S made a motion to adopt and pursue the Healthy Congregations program for Christ Lutheran Church. The motion was seconded and passed. Yes-7, N-0, Abstained-1

1) The meeting was called to order by James Ingraham, President of Council As provided by the CLC Constitution §C10.02 the Congregation Council calls this special Congregational meeting to consider the following specific business: Election of 2018 Congregation Council; Approval of 2018 Budget and Approval of the Strategic Transition Plan. No other business shall be transacted at this meeting.

39 voting members of the congregation shall constitute a quorum for this meeting. (Ref Constitution §C8.02(C) & §10.04 and Active Confirmed Membership of 196

Per the 2016 Annual Report)

The tellers reported that 67 members were present.

Election of Congregation Council Members was chaired by Sandra Boclair,
 Member of Council.

As provided by the CLC Constitution §C5.03(i) and §C12.02, the Congregation is authorized to elect its Congregation Council. The members of the Council shall be elected by written ballot to serve for two years. Such members shall be eligible to serve no more than two full terms consecutively. No nominations from the floor were received. A motion to elect the ballot by acclimation was made and seconded. Ballot approved by acclimation.

- Trent Hizer for a term commencing January 1, 2018 and ending December 31, 2019
- 3) Presentation of 2018-2019 Strategic Transitional Plan was chaired by Carol Jones, Member of Council.
  - WHEREAS, based on the strengths, weaknesses, opportunities and challenges identified through the survey of our membership and;
  - WHEREAS, the result of the analysis of these factors by Vision Team's Strategic Transition
    Plan require establishment of Congregation-approved objectives designed to guide us
    through the transition to a new called pastor; be it

RESOLVED that the Congregation, in accordance with §C5.03 of our constitution, delegates
to the Council the authority to proceed to implement the 2018-2019 Strategic Transition
Plan.

Motion was made and seconded to approve the Strategic Transition Plan. There was no discussion. Congregation voted unanimously to approve the plan.

4) Presentation of 2018 Expense Budget chaired by Mat Lewis, Member of Council.

As provided by the CLC Constitution §C5.03(e) and §C12.05 (c) the Congregation is authorized to approve the annual budget prepared by the Council. A motion was made and seconded to approve the proposed 2018 Operating Budget. No questions or discussion received. Congregation voted unanimously to approve the 2018 Operating Budget.
